What Is the Primacy of Expertise? Since When Have We Come to Realize the Need for Experts?

The terms of using the device, necessary precautions and warnings regarding its level and mode of operation are specified in the "utilization" phase.

The final phase, that is maintenance and repair, determines where to go if any problem arises, how to repair the device and how to contact the manufacturer or authorized support centers.

Additionally, each phase includes crucial points and warnings, which if ignored, could lead to irreparable damage to the system.

When and Where Do We Consult an Expert?

Normally, we follow the principle of the 'primacy of expertise' in everything. But "What is the primacy of expertise?" "What is it about?" To further clarify this, let us consider another example. Imagine receiving a precious and rare plant seed as a gift from one of your dearest friends. Do you seek advice from some skilled gardeners about optimal growing conditions and environmental factors before planting it, or do you just plant the seed in the first pot at hand?
